DDS VOLUNTEER DENTIST SPOTLIGHT

Dr. Charles Cullen

In 2003 Dr. Charles Cullen, a semi-retired Albuquerque dentist, began volunteering with Donated Dental Services, and has assisted 15 DDS patients to date.

Dr. Cullen has spent a lifetime giving back. He began practicing dentistry in the military in 1953, then started his own private practice in Albuquerque. Throughout his practicing years, he has gone voluntarily to Mexico to set up five separate dental clinics through the St. Jude Express over a 25-year period. He has worked with the Healthcare for the Homeless for many years donating dental treatment as well.

NM Dental Relief Fund Update

In July 2006, the New Mexico Dental Foundation began administering the New Mexico Dental Relief Fund that had previously been handled by the NMDA. This account is funded by dentists who donate to it at the time they pay their annual NMDA dues.

At the state level, this fund assists dentists who are experiencing practice threatening situations. Most recently, the fund assisted a dentist who suffered a disabling and life threatening illness. On a national level, the ADA Charitable Assistance Fund will also assist New Mexico dentists and their families who continue to need some financial assistance due to such things as a personal tragedy or natural disaster. In addition, the ADA Fund offers educational assistance for dental, dental hygiene, dental assistant and dental technician students.
